



#### – Note

This DF KIT allows variable settings. Check the zero position before installation. The zero position can be reversed. We do this by loosening the lock nut M9 x 0,7 and next step turn the PCB board with ALPS potentiometer with the 180 degrees.





## HOW TO CHANGE THE INPUTFADER UNIT

#### **■**Change IF-25 SLIDE FADER to DF-25

- ① Re1.Remove the fader knobs. (See fig-a)
- ② Remove the 4 screws which fix the input fader panel to the mixer.
- Remove the unit IF and reconnect all multi-cables conectors (See fig-d)
- 4 Insert the unit DF and connect all multi-cables conectors and fix the unit with 4 screws the input panel to the mixer (See fig-c/b)
- (5) Replace the fader unit making sure that the connector wires are securely fastened before carefully positioning the fader unit and affixing with screws.


Use a plus driver fitting screw.
